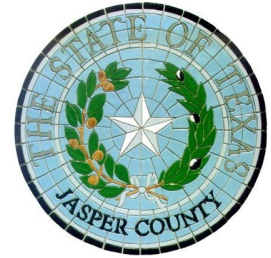

LOCAL COVID-19 NEWS



According to local news sources, the Health District currently has 105 active cases. The Health District has verified that Jasper County will receive another 1600 doses of the vaccine this week for distribution to citizens. The Health District has asked that anybody wishing to receive the next round of vaccine wait until this Wednesday (Jan 27th) to call to be scheduled to ensure that the Health District has the next allocation on site. They ask that due to the COVID-19 exposure risk, all individuals wanting to be vaccinated call first and not show up directly without an appointment.
